





## INTRODUCTION

The teaching team of the Law, Economics and Management Department aims to offer students a wide range of training to enable them, after the degree, to either continue their university career in the master's degree of their choice or to find employment. The Social and Economic Administration Licence is a multidisciplinary course.

## **OBJECTIVES**

The Social and Economic Administration degree aims to train versatile managerial staff with solid knowledge of the three main fields of law, economics and management. Our Social and Economic Administration degree is also unique for its focus on professionalization. This includes preparation for administrative entrance exams and the completion of a compulsory one-month internship in the third year. Lastly, the involvement of industry professionals in the course brings a complementary perspective to theoretical teaching and gives students direct contact with managers.
